Dear Parents and Skaters:

2009 Summer Contract must be postmarked by May 15, 2009.

Summer Contract Information You Need to Know:

- We will be holding an exhibition on Tuesday, July 7th from 4:30-7:40 for our skaters who want to prepare for the upcoming competitions during the summer. The fee is \$10 per program per session, and this cost does include practice ice. **Competition programs only.** Space is limited and seniority rules will apply.
- A 50-minute Ice Dance session will be offered again this summer from 7:30 – 8:20 a.m. on Thursday mornings for those of you that are interested in learning or improving your ice dance skills. Dawn & Michael will coordinate teaching these group ice dance sessions.
- Vacation vouchers will again be offered this summer. (see attachment)

Burnsville-Minnesota Valley Figure Skating Club Training Program: With the chart listed below in mind, the following training program has been designed to encourage our skaters to strive to become U.S. Figure Skating Gold Medalists. Skaters contracting for four or five sessions will receive a 5 percent discount on their total contracted summer sessions. Skaters contracting for six or more sessions this summer will receive a 10 percent discount on their total contracted summer session. (Synchro does not qualify as a contracted session.) One goal and purpose of our club is to encourage the instruction, practice, and advancement of our figure skaters. With that goal in mind, our professional Home Club coaches have put together a “rule of thumb” chart for the amount of ice sessions an average skater should contract to advance to the next test level:

Limited Beginner/Beginner:	2 to 3 sessions per week	Pre-Juvenile to Juvenile	6 to 7 sessions per week
Pre-Preliminary	3 to 4 sessions per week	Intermediate to Senior	7 to 12 sessions per week
Preliminary	4 to 5 sessions per week		

***FYI** – if you’ve recently passed your Pre-Preliminary Field Moves test, you must contract a minimum of 3 sessions per week, per Policy 3.02.

****Junior Club Package** – We have put together a package price for Junior club skaters who want to purchase an additional session in the summer. This will better prepare them for when they choose to advance to Senior club. They do not need a coach assigned in order to do this. The session offered, in addition to the Junior club session, is either Thursdays 6:50-7:40pm, or Fridays 8:00-8:50am. The package price is \$275 for both sessions. Please circle, on the bottom of the contract Thur.7 or Fri. 1, if you wish to take advantage of this offer.

****Off-ice Classes** - Katie Sutherland will once again be offering several off-ice classes during the summer. All skaters are encouraged to participate in at least 1 class this summer. More information will be coming soon.

****Membership applications** – are due with the summer contract. Please complete the form along with the code of conduct and send with your summer contract. MONITOR REQUEST FORM

The Burnsville-Minnesota Valley Figure Skating Club has adopted the following method of assigning monitors to ice sessions. If you would like to be a monitor, please read on. It's easy, and you earn a coupon for each session you monitor.

Monitors will be assigned by seniority based on one session per skater. If you would like to monitor, please submit your request, with your contract to the contract chair by the contract due date. Please include all sessions you could monitor in order of your preference in case your first choices are taken. Sessions will be assigned one at a time based on seniority and number of skaters in the family and will continue through the list a second time and so on until all sessions have been assigned. You will be notified of the assignments given to you. Late requests will be considered after all on-time requests have been filled. Monitors must be adults and cannot monitor a session they are skating on without prior consent of the BMVFSC Board of Directors.

Because of safety issues concerning our skaters and spectators and because the duties of a monitor are to monitor and enforce appropriate and expected skating behavior on a session, no one will be allowed in the monitor's box (Policy 2.01, 2.03). By signing up to monitor, you agree to enforce this rule.

Vacation Vouchers

Vacation vouchers. The board of directors is pleased to announce that the club will again be offering two one-week vacation vouchers for contracted Burnsville-Minnesota Valley Figure Skating Club home club members only. The club will be issuing skating Vacation Vouchers. For every session you miss, you will receive one coupon of equal value that you will be able to use to buy into a session from Fall 2009 to Spring 2010. No money will be refunded. The following rules will apply and **must** be adhered to:

- The vacation vouchers may only be submitted during the Summer 2009 contract – June 8 – September 7, 2009.
- **You must** write “*Vacation*” by your skater’s name on **ALL** of the sessions they skate on the monitor’s sheets. **(If you do not write vacation by your skater’s name, you will not receive a coupon for it).**
- The monitor will put their initials by the skater’s name to verify that they are not on the ice.
- You must use these as *weekly* vacation vouchers – not *daily* vouchers. In other words, you cannot take a day off here and there. (For example: Mary will be on vacation on Tuesday, Wednesday, and Thursday during the second week in July. That’s fine. Fill out your vacation voucher and follow the rest of the rules. Jane will be on vacation on June 18, July 2, July 15, and August 10. Sorry, you can’t get coupons for four weeks or four sessions. However, you can get coupons for the two sessions that you missed within a two-week period of time.
